The regular meeting of the BBMUA was held on March 28, 2012 at 7 p.m. This meeting notice was provided to The Daily Journal and the Atlantic County Record which are the BBMUA's official newspapers. Notices are also posted on the bulletin boards within the Municipal Building as well as the Borough of Buena and BBMUA's websites. The meeting took place in the large meeting room located in the Municipal Building, Minotola.

The meeting was called to order by John Brunini chairman.

Chairman John Brunini received a letter from James Pontoriero, Supervisor of the Bureau of Construction and Connection Permits of the State of NJ DEP Division of Water Quality granting the treatment works approval for the Lewis Drive Sanitary Sewer Extension which will be valid for a period of 2 years from the date of issuance which is March 20, 2012. The Borough of Buena and the BBMUA are working together to get this project in motion.

Robert Smith of Remington, Vernick & Walberg reported that the 2011 Treatment Plant Upgrade project has begun as of February 29, 2012 the contractor mobilized all equipment and is now on site, installed template and construction entrance, silt fence and project sign and has excavated and installed platform footings. As of March 26, 2012 continued installation of footings and foundation walls of the MRB building and started the influent force main installation and electrical.

Alan Zorzi the BBMUA's plant superintendent informed the board that a new recycle pump has been ordered from Falasca Mechanical to replace the pump that has been in for repair with Deltronics. The old pump was returned by Deltronics and will be kept for spare parts.

Mr. Zorzi also informed the board that on Tuesday, March 27, 2012 there was a strange citronella odor at the plant which was traced to a bug spray manufactured by our customer IGI for Target. Apparently IGI had a broken pipe and lost approximately 200 gallons of product that was discharged into the sewer system. He contacted IGI in regard to cleanup and the President of IGI agreed to take full responsibility and cover the cost of the clean up of this spill. Mr. Zorzi contacted the DEP and let them know what was happening at our plant and a notice of violation has been issued to IGI by the DEP directly. All costs in the cleanup will be billed directly to IGI by the contractor hired to cleanup the spill. If IGI refuses to pay the charges involved in the cleanup we will proceed according to the terms and conditions set out in the emergency declaration of Title 40A.
