Secretary/Treasurer Cheryl Santore informed the board that a memo was received from Stephen Sacco, Executive Director of the New Jersey Municipal Environmental Risk Management Fund (EJIF) regarding a claims sweep for Perflurooctanoic Acid (PFOA) and Perfluorooctane Sulfonate (PFOS). They are requesting that any written notice from an attorney representing a party indicating a future claim be submitted prior to December 16, 2022. Ms. Santore stated that we have not been notified of any future claims and Plant Superintendent Alan Zorzi stated we have not had any problems with this.

Ms. Santore received a memo from Michael Palsi, Risk Consultant for J.A. Montgomery Consulting for the NJUAJIF regarding the Loss Control Survey that was conducted on September 13, 2022. The survey revealed well-organized and clean facilities and resulted in no new suggestions for improvements and no outstanding suggestions for improvements. Chairman Santagata congratulated Plant Superintendent Alan Zorzi and the employees at the plant for their good work.

Ms. Santore informed the board that she spoke with Mary Ann Chalow and she has agreed to renew her consulting services with the BBMUA for another year beginning September 1, 2022 through August 31, 2023. Therefore, the board must adopt resolution R-20-2022.
