The BBMUA's engineer Robert Smith informed the board members that after tabulating all the bids that were received on September 27, 2011 for the (2011 Project) it was determined that the low bidder was Level-1 Construction, Inc. in the amount of \$3,912,000.00 representing bid items #1-#15. The board members should be awarding the bid at their next regular meeting to be held on November 9, 2011 contingent upon approval of the MUA's solicitor, USDA and monies being available.

The BBMUA's auditor Steve Testa discussed the interest rates that were received from various banks for the Bond Anticipation Notes for the BBMUA's (2011 Project). The rates that were received were 0.75% from Susquehanna Bank, 1.00% from Newfield National Bank and the only other was 1.446% from Capital Bank of New Jersey.

The board members discussed correspondence number (4) from Mr. Dennis Steudle concerning the General Liability Notice of Occurance/Claim that he completed for his sewer backup at his residence so that the MUA could forward it to our insurance company. Michael Testa, Jr. the MUA's solicitor said that within the rules and regulations of the BBMUA any problem inside the curb line including the laterals are not the responsibility of the BBMUA. He also stated that if his plumbing fixtures as well as his check valves failed it wasn't the BBMUA's obligation to pay for his damages. Mr. Testa also stated that it appears that Mr. Steudle will likely bring this matter to litigation.
