Robert Smith of Remington, Vernick & Walberg notified the board that the advertisement for the bids for wood chips, liquid alum and water meters have been advertised and will be opened on Tuesday, December 18, 2013 and that the advertisements for bids for mechanical and electrical repair and maintenance will be advertised and bids will be opened on January 9, 2013 at 11:00 am.

Chairman Brunini asked Mr. Smith to continue looking into solar options available to the MUA. Mr. Smith informed the Chairman that they have begun looking into options that would utilize the 2 acre parcel that was recently acquired adjacent to the plant and roof top units on some of the structures on site at the plant.

Michael Testa Jr. of Testa, Heck, Scrocca & Testa contacted Ralph Laks regarding the pumping station at Minotola Estates. Mr. Laks was mailed a letter today with several exhibits stating very clearly that the spirit and intent of both parties was to turn the pumping station and ownership over to the BBMUA. Robert Smith is going to look into the bonds that were posted for this project. Michael Testa Jr. is going to conduct a search to see if the easement was ever filed for the pump station. It was recommended that a meeting be set up with Mr. Laks to find out the details on ownership and the funds to be

refunded to Mr. Laks for the remainder of the lots that are not connected to the system and will not be developed.
