AUDITOR'S REPORT: #2 When the Authority previously issued its Series 2003A Bonds we agreed to comply with any continuing requirements that may be necessary to preserve the exclusion from gross income of interest on the Bonds for purposes of federal income tax. Compliance under this code is referred to at Arbitrage Rebate Compliance. Originally the BBMUA and Bond Council were under the impression that we did not have to do this, however, when speaking with Phoenix Advisors regarding the MCDC Initiative it was discovered that we are required to perform and Arbitrage calculation yearly on these bonds. Therefore, the BBMUA's Auditor, asked Phoenix to submit a proposal to get the BBMUA caught up with the rebate obligations. Phoenix submitted a proposal in the amount not to exceed \$3,000.00 to review, analyze, monitor, advise, and assist the BBMUA on all rebate matters in connection with its continuing Arbitrage rebate compliance.
