LIQUID ALUMINUM SULFATE

**WHEREAS**, the Borough of Buena Municipal Utilities Authority (hereafter the “Authority”) has arranged for the publication of specifications and terms for the furnishing and delivery of liquid aluminum sulfate for the period of January 1, 2021 to December 31, 2022; and

**WHEREAS**, the Authority’s Engineer, Remington & Vernick Engineers, as required by law, caused to be published specifications for the bidding of such work in accordance with the relevant New Jersey Statute prescribing publication in such matters; and

**WHEREAS**, it is necessary and proper that the Authority confirm all action taken by its Engineer, any publication of the specifications seeking bids; and

**WHEREAS**, upon proper application, bids were received, open and read on December 3, 2020 at 11:00 a.m. by the Authority at the Borough of Buena Municipal Building located at Central Avenue in Minotola, New Jersey; and

**WHEREAS**, Univar Solutions USA, Inc. having its principal place of business at 200 Dean Sievers Place, Morrisville, Pennsylvania 19067, submitted the lowest responsible bid in the amount of \$36,920.00 for the furnishing and delivery of liquid aluminum sulfate; and

**WHEREAS**, the Authority’s Engineer, Remington & Vernick Engineers has recommended that the Authority accept the lowest responsible bid submitted by Univar Solutions USA, Inc; and

**WHEREAS**, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

**NOW, THEREFORE, BE IT RESOLVED** that all action taken by the Authority’s Engineer, Remington & Vernick Engineers, in publishing specifications for bids and the

subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible bid for the published services, be and these actions are hereby confirmed and approved.

**BE IT FURTHER RESOLVED** that the Secretary of the Authority is hereby authorized to return all bids, certified checks and/or bid bonds to any and all rejected bidders.

**BE IT FURTHER RESOLVED** that the proper officers of the Authority be and they are hereby authorized to execute any and all documents required with respect to the awarding of a one-time contract fee in the amount of \$36,920.00 for the furnishing and delivery of liquid aluminum sulfate.

Dear Chairman:

We have reviewed the bid received on December 3, 2020 with reference to the above captioned project. One bid was received from Univar Solutions USA, Inc., 200 Dean Sievers Place, Morrisville, Pennsylvania 19067 with a bid in the amount of \$36,920.00. This equates to furnishing and delivery of 26,000 gallons of liquid aluminum sulfate at a unit price of \$1.42 over a two (2) year contract term.

Therefore, in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq., the contract should be awarded to the lowest responsible bidder, which appears to be Univar Solutions USA, Inc. with a bid in the amount of \$36,920.00. The award should be contingent upon approval of the MUA Solicitor and funds being available.

Based upon our review of the bid, we noted the following:

- The "New Jersey Business Registration Certificate" Form, the Debarred List Affidavit, the Non-Collusion Affidavit, the Affirmative Action Requirements form, and the Certificate of Bidder Showing Ability to Perform Contract have an original signature by the bidder, however, the Notary's information block does not appear to be original.
- The Background Questionnaire did not provide addresses for the officers.

The above issues are deferred to the Board Solicitor for review.

By copy of this letter, we have provided Mr. Testa and Mr. Caselle with a copy of the bid via e-mail. If Mr. Testa or Mr. Casella need to see originals of any documents, I would request that they contact my office.


