WHEREAS, the Authority's Engineer, Remington, Vernick & Walberg has recommended that the Authority accept the lowest responsible bid as submitted by Warriner's Construction, Inc.; and

WHEREAS, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that all action taken by the Authority's Engineer, Remington, Vernick & Walberg, in publishing specifications for bids and the

BE IT FURTHER RESOLVED that the Secretary of the Authority is hereby authorized to return all bids, certified checks and/or bid bonds to any and all rejected bidders.

BE IT FURTHER RESOLVED that the proper officers of the Authority be and they are hereby authorized to execute any and all documents required with respect to the awarding of a one-time contract fee in the amount of \$30,240.00 for the furnishing and delivery of wood c hips.
