RESOLUTION AWARING CONTRACT FOR
PROFESSIONAL SERVICES PURSUANT TO THE
FAIR AND OPEN PROCESS TO WINNE BANTA
FOR BOND COUNSEL SERVICES

WHEREAS, pursuant to the Fair and Open Process on January 8, 2019, the Borough of Buena Municipal Utilities Authority (hereinafter referred to as the “BBMUA”) received, publicly opened, and read qualifications submitted in response to a Request for Qualifications for Bond Counsel; and

WHEREAS, the BBMUA authorizes the Chairman and the Secretary of the BBMUA to retain the Professional Services of Bond Counsel in accordance with the Fair and Open Process

WHEREAS, one (3) firms, Winne Banta Basralian & Kahn, P.C., 21 Main Street, Suite 101, Hackensack, New Jersey 07601, Parker McCay P.A., 9000 Midlantic Drive, Suite 300, Mt. Laurel, New Jersey 08054, and McManimon, Scotland & Baumann, LLC Attorneys at Law, 75 Livingston Avenue, Roseland, New Jersey 07068 submitted qualifications in response to the Request for Qualifications; and

WHEREAS, the qualifications submitted were evaluated in accordance with the criteria set forth; and

WHEREAS, it was determined that the qualifications submitted by Winne Banta Basralian & Kahn, P.C. met the submission requirements; and

WHEREAS, funds are available for this purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE BBMUA as follows:

1. The Chairman of the BBMUA is hereby authorized and directed to execute the agreement filed with the Secretary and with Winne Banta Basralian & Kahn, P.C.

to supply bond counsel services for the period of February 1, 2019 through January 31, 2020 for the hourly rate of \$150.00 per hour if utilized.

2. This Contract is awarded in accordance with the Fair and Open Process procedures pursuant to the provisions of N.J.S.A. 19:44-20.4.
3. A notice of Contract Award shall be published in the Atlantic County Record and in the Daily Journal as required by law within ten (10) days of its passage.
4. The Bond Counsel's Professional Services Agreement, as well as a copy of this Resolution, shall be maintained on file in the Office of the Secretary of the Authority, where such documents shall be available for public inspection during normal business hours.
