RESOLUTION RATIFYING AWARD OF AN EMERGENCY PURCHASE CONTRACT
FOR AN EMERGENCY REPAIR ON WELL NO. 2 BY AC SCHULTES, INC.

R-16-2022

WHEREAS, the Borough of Buena Municipal Utilities Authority (BBMUA) supplies potable water throughout Buena Borough and Buena Vista Township; and

WHEREAS, the BBMUA operates three wells to supply the potable water one being well no. 2 which is the second largest production well and is critical for the potable water supply to meet system demands; and

WHEREAS, well no. 2 has an emergency generator and is needed to ensure an ample supply of potable water throughout Buena Borough and Buena Vista Township to the residents and businesses; and

WHEREAS, the above-described conditions have created an emergency that affect the public health, safety and welfare which requires the immediate delivery of goods and the performance of repair services; and

WHEREAS, the Superintendent notified the Chairman and Board of the nature of the emergency, the time of its occurrence and the need for an emergency repair contract; and

WHEREAS, the Local Public Contracts Law, at N.J.S.A. 40A:11-6, provides that “any contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of service;” and

WHEREAS, AC Schultes Inc., of Woodbury Heights, New Jersey has the qualifications, equipment and personnel that are necessary to perform the required emergency repair; and

WHEREAS, the estimated cost of the emergency repair is \$25,000.00; and

WHEREAS, the Plant Superintendent has made a full report of the details of this matter to the Board;

NOW, THEREFORE, BE IT RESOLVED, by the Borough of Buena Municipal Utilities Authority, in the County of Atlantic and State of New Jersey, as follows:

- 1) All of the statements of the preamble are incorporated herein by this reference thereto as though the same were set forth at length.

- 2) The appropriate officials are authorized to take all actions that are necessary and proper and are authorized to execute the necessary documents so as to provide payment to AC Schultes Inc. for the goods delivered and the services performed in connection with the emergency motor replacement and/or repair contract.
- 3) This resolution only shall be effective when a Certification of Funds from the Authority's Certifying Finance Officer is issued and annexed.
- 4) The Chairman shall cause such reports as may be required by the State of New Jersey, Division of Local Government Services, relative to emergency contracts to be prepared and filed.
