RESOLUTION AWARDING CONTRACT FOR FURNISHING AND DELIVERY OF  
LIQUID ALUMINUM SULFATE

**WHEREAS**, the Borough of Buena Municipal Utilities Authority (hereafter the “Authority”) has arranged for the publication of specifications and terms for the furnishing and delivery of liquid aluminum sulfate for the period of January 1, 2019 to December 31, 2020; and

**WHEREAS**, the Authority’s Engineer, Remington, Vernick & Walberg, as required by law, caused to be published specifications for the bidding of such work in accordance with the relevant New Jersey Statute prescribing publication in such matters; and

**WHEREAS**, it is necessary and proper that the Authority confirm all action taken by its Engineer, any publication of the specifications seeking bids; and

**WHEREAS**, upon proper application, bids were received, open and read on November 20, 2018 at 11:00 a.m. by the Authority at the Borough of Buena Municipal Building located at Central Avenue in Minotola, New Jersey; and

**WHEREAS**, Univar USA, Inc. having its principal place of business at 200 Dean Sievers Place, Morrisville, Pennsylvania 19067, submitted the lowest responsible bid in the amount of \$33,540.00 for the furnishing and delivery of liquid aluminum sulfate; and

**WHEREAS**, the Authority’s Engineer, Remington, Vernick & Walberg has recommended that the Authority accept the lowest responsible bid submitted by Univar USA, Inc; and

**WHEREAS**, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.



**BE IT FURTHER RESOLVED** that the Secretary of the Authority is hereby authorized to return all bids, certified checks and/or bid bonds to any and all rejected bidders.

**BE IT FURTHER RESOLVED** that the proper officers of the Authority be and they are hereby authorized to execute any and all documents required with respect to the awarding of a one-time contract fee in the amount of \$33,540.00 for the furnishing and delivery of liquid aluminum sulfate.
