RESOLUTION AMENDING AN EMERGENCY PURCHASE CONTRACT
FOR AN EMERGENCY REPAIR ON THE SLUDGE MIXING TRUCK
FROM BAYVIEW BEARING & SUPPLY, L.L.C

R-21-2021

WHEREAS, the Borough of Buena Municipal Utilities Authority (BBMUA) processes wastewater serving Buena Borough along with septage received from numerous homes and businesses throughout the area; and

WHEREAS, the BBMUA operates a belt filter press to dewater digested sludge that is discharged into a sludge mixing truck; and

WHEREAS, processing solids for disposal is critical to maintaining proper operation balances and the mixing and discharge screws on the truck have started to fail and the screws can no longer safely discharge the dewatered sludge critical to this process; and

WHEREAS, the above-described conditions created an emergency that affected the public health, safety and welfare as well as created an unsafe working environment to the BBMUA Staff which required the immediate delivery of goods and the performance of repair services; and

WHEREAS, the BBMUA Chairman and Board adopted a resolution awarding an emergency purchase contract for an emergency repair of the sludge mixing truck to Bayview Bearing and Supply, L.L.C. at its regular meeting held on January 13, 2021 in the amount not to exceed \$52,000.00; and

WHEREAS, Bayview Bearing & Supply, L.L.C. while making the repairs discovered additional items that needed to be replaced and repaired to make the sludge truck operate safely and effectively for an additional cost of \$5,281.65 which brings the total emergency repair cost to \$57,281.65;

NOW, THEREFORE, BE IT RESOLVED, by the Borough of Buena Municipal Utilities Authority, in the County of Atlantic and State of New Jersey, as follows:

- 1) The BBMUA Board hereby authorizes the additional funds expenditure to Bayview Bearing & Supply, L.L.C. in the amount of \$5,281.65 which added to the previously approved amount of \$52,000.00 will cover the total invoice amount of \$57,281.65.
- 2) The appropriate officials are authorized to take all actions that are necessary and proper and are authorized to execute the necessary documents so as to provide payment to Bayview Bearing & Supply, L.L.C. for the goods delivered and the services performed in connection with the emergency mixing and discharge repair contract.

- 3) This resolution only shall be effective when a Certification of Funds from the Authority's Certifying Finance Officer is issued and annexed.
