MUNICIPAL MAINTENANCE COMPANY THROUGH  
THE NORTH JERSEY WASTEWATER COOPERATIVE PRICING SYSTEM

**WHEREAS**, the Borough of Buena Municipal Utilities Authority (hereafter "Authority") is a party to a cooperative program pursuant to the Local Public Contracts Law N.J.S.A 40A: 11-10; and

**WHEREAS**, the Local Public Contracts Law authorizes a municipal authority to purchase goods and services through a duly- formed cooperative purchasing system without advertising for bids; and

**WHEREAS**, the North Jersey Wastewater Cooperative Pricing System (NJWCPS) has awarded a cooperative Purchasing Contract for Various Manufacturer Pumps and Motors Repair Replacement and Installation (Contract #B369-4) for installation of customer supplied parts in a Komline Sanderson Piston Pump to be supplied by Municipal Maintenance Co. having a business address at 1352 Taylors Lane, Cinnaminson, NJ 08077

**WHEREAS**, the Authority is in need of purchasing the labor to install customer supplied parts in a Komline Sanderson Piston Pump; and

**WHEREAS**, the procurement of goods and services through a cooperative purchasing program is an "open and fair process" under the New Jersey Pay-to-Play Law, N.J.S.A 19:44A 20:5 et seq.;

**NOW, THEREFORE, BE IT RESOLVED**, that the Authority enter into an agreement with Municipal Maintenance Co. for the installation of customer supplied parts in a Komline Sanderson Piston Pump in accordance with the afore mention contract attached hereto, in the amount not to exceed nine thousand two hundred seventy dollars (\$9,270.00); and

**BE IT FURTHER RESOLVED**, that the proper officers of the Authority be and they are hereby authorized to execute any and all documents required with respect to the contract for the furnishing of labor to install customer supplied parts in Komline Sanderson Piston Pump by Municipal Maintenance Co. having a business address at 1352 Taylors Lane, Cinnaminson, NJ 08077.
