The Authority will be discussing tactics and techniques utilized in protecting and safeguarding property of the public and such disclosure could impair such protection. N.J.S.A. 10:4-12(b)(6).

\_\_\_\_\_ The Authority will be discussing an investigation of violation or possible violation or possible violation of the law. N.J.S.A. 10:4-12(b)(6).

\_\_\_\_\_ The Authority will be discussing litigation. N.J.S.A. 10:4-12(b)(7).

\_\_\_\_\_ The Authority will be discussing matters which involve attorney client privilege. N.J.S.A. 10:4-12(b)(7).

\_\_\_\_\_ The deliberations of the Authority after a public hearing may result in an imposition of a specific civil penalty or suspension or loss of a license or permit belonging to the responding party for which the responding party bears responsibility. N.J.S.A. 10:4-12(b)(9).
