**WHEREAS**, the Borough of Buena Municipal Utilities Authority (hereafter the “Authority”) has arranged for the publication of specifications and terms for the furnishing and delivery of water meters to the Authority for February 11, 2019 to February 10, 2020; and

**WHEREAS**, the Authority’s Engineer, Remington, Vernick & Walberg, as required by law, caused to be published specifications for the bidding of such work in accordance with the relevant New Jersey Statute prescribing publication in such matters; and

**WHEREAS**, it is necessary and proper that the Authority confirm all action taken by its Engineer, any publication of the specifications seeking bids; and

**WHEREAS**, upon proper application, bids were received, open and read on December 18, 2018 at 11:00 a.m. by the Authority at the Borough of Buena Municipal Building located at Central Avenue in Minotola, New Jersey; and

**WHEREAS**, Rio Supply, Inc. having its principal place of business at 100 Allied Parkway, Sicklerville, New Jersey 08081, submitted the lowest responsible bid in the amount of \$44,100.00 for the furnishing and delivery of water meters; and

**WHEREAS**, the Authority’s Engineer, Remington, Vernick & Walberg has recommended that the Authority accept the lowest responsible bid as submitted by Rio Supply, Inc.; and

**WHEREAS**, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.


