RESOLUTION AUTHORIZING THE ENTERING INTO OF AN EXERCISE SERVICES ACT AGREEMENT FOR INTERIOR CONNECTION OF THE CITY OF VINELAND WITH THE BOROUGH OF BUENA MUNICIPAL UTILITIES AUTHORITY

WHEREAS, the Borough of Buena Municipal Utilities Authority is desirous, under N.J.S.A. 40:8A-1 et seq. (Interlocal Services Act), of entering into an Agreement with the City of Vineland to interconnect their two systems at Vine and Brewster Roads, in the City of Vineland, and
